

REGIONAL PUBLIC DEFENDER PROPOSAL

REGION 1.

Consisting of 11th, 19th, 20th Judicial Districts
Main Office: Kalispell
Satellite Offices: Polson & Libby
Kalispell Office would service all of the 11th Judicial District
Polson Office would service all of the 20th Judicial District
Libby Office would service all of the 19th Judicial District

REGION 2.

Consisting of 4th and 21st Judicial Districts
Main Office: Missoula
Satellite Office: Hamilton
Missoula Office would service all of the 4th Judicial District
Hamilton Office would service all of the 21st Judicial District

REGION 3.

Consisting of 8th and 9th Judicial Districts
Main Office: Great Falls
Satellite Office: Shelby
Great Falls would service all of the 8th Judicial District
Shelby would service all of the 9th Judicial District

REGION 4.

Consisting of 1st Judicial District, and that portion of the 5th Judicial District that is Jefferson County.
Main Office: Helena
Helena Office would service the entire area with contract attorneys as needed.

REGION 5.

Consisting of 2nd, 3rd, the 5th (excluding Jefferson County) Judicial Districts
Main Office: Butte
Butte Office would service all 3 Judicial Districts with possible contract attorneys or Satellite offices in Dillon and Virginia City

REGION 6.

Consisting of 12th Judicial District and part of the 17th Judicial District
Main Office: Havre
Havre Office would service the entire area, anticipating some contract attorneys where needed in possibly Malta or Fort Benton

REGION 7.

Consisting of 10th Judicial District and the 14th Judicial District
Main Office: Lewistown
Lewistown Office would service the entire area, with possible contract attorneys as needed in Roundup.

REGION 8.

Consisting of 6th and 18th Judicial Districts

Main Office: Bozeman

Bozeman Office would service entire area with possible contract attorneys in Livingston or West Yellowstone.

REGION 9.

Consisting of 13th and 22nd Judicial Districts

Main Office: Billings

Billings Office would service the entire area, with possible Satellite Offices in Hardin and/or Red Lodge if needed. Red Lodge would service the entire western half of the 22nd Judicial District, Hardin the east half of the 22nd Judicial District

REGION 10.

Consisting of 15th, 7th, & that portion of the 17th Judicial District east of Malta

Main Office: Either Glendive or Glasgow [depending upon the numbers] with contract attorneys as needed in Sidney, Glasgow, or Glendive.

REGION 11.

Consisting of 16th Judicial District

Main Office: Miles City

Miles City Office would service the entire area, with contract attorneys as needed.
